# Town Justice in Wayne County Resigns While Under Investigation After Pleading Guilty to Criminal Contempt

Michael Ralph Miller, a Justice of the Arcadia Town Court and the Newark Village Court, Wayne County, resigned while under investigation by the New York State Commission on Judicial Conduct after pleading guilty to violating a stay-away order of protection held by a former girlfriend.

In October 2020, the judge pled guilty to criminal contempt in the second degree, a misdemeanor, and was sentenced to three years' probation. The guilty plea was in satisfaction of original charges that included stalking a former girlfriend. The sentence included a five-year, no-contact final order of protection for the victim, waiver of appeal, a requirement that he attend domestic violence and mental health counseling, and payment of fees totaling \$250.

Judge Miller, who left office on April 16, 2021, agreed never to seek or accept judicial office at any time in the future. The Commission accepted a stipulation to that effect signed by the judge, his attorney and the Commission's Administrator and closed its investigation.<sup>1</sup>

Judge Miller waived the statutory provision of confidentiality applicable to Commission proceedings, to the limited extent that the stipulation and Commission's order accepting it and closing the case would be public.

Judge Miller, who is an attorney, had been a Justice of the Arcadia Town Court, and the Newark Village Court, since 2010. His current terms would have expired on December 31, 2022.

#### **Statement by Commission Administrator**

Commission Administrator Robert H. Tembeckjian made the following statement.

"There is no room on the bench for a judge who is convicted of a serious criminal offense that arises out of stalking a former girlfriend. The public can have no confidence in a person who violates the very law he is sworn to uphold. Judge Miller's resignation and commitment never to return are entirely appropriate in these circumstances."

#### **Statistics Relating to Prior Commission Decisions**

The Commission has accepted 105 such stipulations since the procedure was instituted in 2003.

Since 1978, the Commission has issued 278 determinations of admonition against judges in New York State, 338 determinations of censure and 175 determinations of removal.

The Court of Appeals has reviewed 101 Commission determinations. The Court accepted the Commission's sanctions in 85 cases (76 of which were removals, six were censures and three were admonitions). Of the remaining 16 cases, two sanctions were increased from censure to removal, and 13 were reduced: nine removal determinations were modified to censure, one removal was modified to admonition, two censures were modified to admonition, and one censure was rejected and the charges dismissed. The Court remitted one matter to the Commission for further proceedings.
